

Rise & Resist: CHD Conference 2023 Summary

From November 3rd-5th, over 1000 attendees from five continents—consisting of 43 speakers, 56 sponsors/exhibitors, and the CHD Bus—converged in Savannah, GA for **Rise & Resist**. The 2nd annual CHD Conference expanded upon the first with three full days of information and opportunities to connect. This is an effort to summarize the tremendous amount of inspiring and instructive content from the presentations given by the 20+ panels covering advocacy, science, medicine, and law.

LAW

The Titanic Can Sink...

CHD has expanded its [portfolio of litigation](#). Two panels and 11 different representatives from the CHD legal team addressed five federal lawsuits and 23+ active cases in seven+ states. As expected, medical freedom was a focus. Groundbreaking vaccine litigation is heading to civil court. Other cases range from Monsanto to masks and address misconduct, parental consent, FDA overreach, and fraud. CHD Legal has challenged medical mandates impacting children and college students (Rutgers) and will soon address the Prep Act. Senior Counsel, Ray Flores, stated, “The Titanic can sink—the Prep Act is unconstitutional.”

CHD Legal is also working to defend our First Amendment rights (with censorship cases against Facebook/Meta, the Trusted News Initiative, and the White House), Fourth Amendment privacy rights (addressing the smart city initiative), and our right to lead a natural life. There are multiple lawsuits involving electromagnetic radiation (EMR) and our public health agencies. CHD is using the Freedom of Information Act (FOIA) to shine a light on the activities of agencies with 30 FOIA requests outstanding and four in active litigation.

Throughout the Conference, the CHD legal team members made themselves accessible to the attendees for questions. This facilitated CHD NE communication about concerns in our state—including the Health Information Technology (HIT) Board and our medical data. Stay in Your Lane: Doctors Treat; Industrial Hygienists Protect

The CHD legal team members are not the only movers and shakers in the legal realm. Industrial Hygienists Tammy Clark and Kristin Kelly appeared on stage in hazmat suits. Through COVID and beyond, they have worked to educate the public and officials about the inefficacy of typical cloth and/or surgical masks and the appropriate protections for an aerosolized virus (personal protective equipment [PPE] and environmental controls). They emphasized that it is medical malpractice for a doctor to say to wear a mask: doctors treat, industrial hygienists protect. Clark and Kelly presented their information in the Supreme Court and exposed the weaponization of regulatory agencies and reestablished precedence. They played key roles in establishing that the White House violated statutory authority and cannot tell regulatory agencies (OSHA and the EPA) what to do.

SCIENCE/MEDICINE

They Don't Know What They Don't Know!

There are many lessons to be learned in public health advocacy. Aseem Malhotra, MD pointed out that due to commercial controls, there is a lack of knowledge in the medical field—but that most doctors don't know that. “Many doctors, and those in the general population, don't know what they don't know.”

[Malhotra, a Cardiologist and best-selling author](#), identified fear and willful ignorance as the greatest barriers to truth. He presented a triangle to frame truth to have difficult conversations with family and

friends—to attempt to “move the mountain.” This consists of relevant knowledge, political involvement, and social participation. He also stressed the importance of evidenced-based, clear advocacy with “killer” attention grabbing facts in a context of a values system. Reaching within can help activate virtuous aspects of human nature and can help mountain moving... as does patience and—last, but not least—a “rhinoceros hide.”

The Vaccine Schedule and Science-Like Activities

Many would argue medical professionals at **Rise & Resist** have developed the “rhinoceros hide” Malhotra referenced. Dr. Sabine Hazan, MD pointed out that “...not every doctor has the courage to stand up here—we have been beaten up.”

Suzanne Humphries, MD, author of *Dissolving Illusions* (2013) covered the history of disease from Smallpox to COVID and addressed the history of vaccine development. Panelists from “The Vaccine Schedule: The Good, The Bad & The Ugly” included Christina Parks, PhD; James Lyons-Weiler, PhD; Brian Hooker, PhD; Paul Thomas, MD; and DeeDee Hoover, OMT, PMT, CCT. They shared their experiences educating the public about the conflicts of interest and the risks associated with the schedule—especially since the 1986 National Childhood Vaccine Injury Act. Critics of the schedule also addressed the lack of long-term testing and true placebo groups—what Lyons-Weiler referred to as “science-like activities.”

The implications of this ever-expanding schedule include, but are not limited to, molecular mimicry, autoimmunity, and chronic immune activation and are presented in the CHD book *Vax-Unvax: Let the Science Speak* by Kennedy & Hooker (2023). This features 100+ peer-reviewed studies comparing and contrasting vaccinated and unvaccinated populations. It is a groundbreaking tool to educate the public and the medical profession about the differences between these populations.

Reform Pharma!

Phar-ma-cide noun or verb: *Death and injury by Big Pharma corruption.*

For Lyons-Weiler, vaccines are a gateway drug to allopathic medicine and to pharmaceutical drugs. The end result often being *Pharmacide—death and injury by Big Pharma*. Mary Holland, CHD President and general counsel, said to add this term to our vocabulary NOW!

Language is powerful, but it is going to take more than a few new words to solve the corruption of Big Pharma. CHD unveiled a new campaign to do just that—[Reform Pharma](#). This 10-point initiative aims to restore medical freedom, separate pharma and state, reform regulatory and oversight agencies, and establish scientific integrity in research publications. Solutions in SCIENCE: Regenerate

Many solutions in science include resetting and regenerating. Dr. Christine Parks focused on the importance of detoxification, which will be featured on her new website in January. “Let’s Discuss Food: Problems and Creative Solutions” panelists including [Meadows BEE Farm](#) and [Food Forest Abundance](#) also addressed important changes—those to our diet and to agriculture. They involve whole foods and the ability to grow them—to regenerate. Common agricultural practices are killing our soil. The loss of microorganisms/bacteria are leading to the gradual inability of our soil to support many functions, such as carbon storage, water filtration, and biodiversity. Regenerative Agriculture involves a paradigm shift from an emphasis largely on production to one on biodiversity and topsoil generation. This is achieved by applying indigenous knowledge, modern research, and respect for farmer wisdom.

Save the Bif!

Alarm bells for soil bacteria were equally loud for what Dr. Sabine Hazan, MD referred to as an “extinction of the human microbiome.” Hazan, a Gastroenterologist and medical researcher, called for a “health care revolution in our gut to save humanity.” Her presentation “The Effects of Medications, Nutraceuticals, and COVID Vaccines on the Microbiome” featured colorful (and not-so-colorful) graphs of our microbiomes.

According to Hazan, the graphs tell stories—stories of health, disease, aging, autism, and COVID. [Hazan's research](#) is based upon collecting stool samples from humans (and other mammals) all over the world. Hazan argued the survival of the human race is reliant upon saving our diverse microbiome and especially Bifidobacterium: “We need to unite and collaborate to make sure humanity will survive the extinction of microbes. We need to reforlizate. We need to save the Bif!” <https://progenabiome.com>

ADVOCACY/EDUCATION

A CHD New World Order: The Future is Bright. We Have Solutions!

A sense of optimism pervaded the “Solutions in the Post-COVID Era” panel. Brian Hooker, PhD reassured everyone that the future is bright. We have solutions! Based on these presentations, it seems not only that there are solutions, but that there is more than one agenda for a New World Order! Many CHD Conference participants envision one that empowers the people with new ways to educate and to advocate in medicine, science, law, and in finance!!

CHD is Your Army

Catherine Austin Fitts, President of the [Solari Report](#), Investment Advisor, and past government official addressed the crisis in our financial system and solutions to take back our power. Fitts identified trillions of missing dollars and that “It is not a financial crisis, it is a financial coup d'état.”

Fitts asserted that “If we don’t fight, we have zero chance: CHD is your army.” To combat the weaponization of population and immigration, Fitts encouraged helping state legislators create conditions of sovereignty via her “[Financial Transaction Freedom](#)” document. In addition to fighting, she stressed the importance of humor and joy, advising we should “stay in a state of amusement and never quit! My plan is to turtle!”

Andrew Wakefield, MD encouraged others to call out corruption and for “unconformity in science.” Science will find a way! James Lyons-Weiler, PhD has found a way. He has taken science out of Academia with the Institute for Pure and Applied Knowledge (aka [IPAK](#)). IPAK features a variety of instructors—many presenting at the Conference—with classes ranging from environmental toxicology to herbology. Lyons-Weiler has also created alternatives to liberate science from captured agencies and journals. He developed a new journal *Science, Public Health Policy, and the Law* to inspire independent research. “Plan B: Public Health Infrastructure and Operations Oversight Reform for America” provides the framework to stop the revolving door system between pharma and government.

Empowering parents is the mission of the “[Kids First Forever](#)” program. Dr. Paul Thomas, MD and DeeDee Hoover, LMT, CCT, PMT have launched an initiative to educate and inform parents on the physical, emotional, mental, and spiritual principles of children’s development. This ranges from nutrition to navigating decisions and conversations in the pediatrician’s office.

Armed with information and perhaps the *Vax-Unvax* book and the latest CHD EMR handouts, parents may soon find themselves with an IPAK aluminum calculator app that can easily provide total aluminum content of proposed vaccines per pediatric office visit. There are many new tools for parents to make informed decisions regarding their children’s health.

Trusting the Experts is Not a Thing!

Executive Vice President, Laura Bono presented the 2023 Defender Award for being a Defender of truth, freedom, and children’s health. This year’s recipient was CHD founder, Chief Litigation Counsel and Chairman on Leave, Robert F. Kennedy, Jr. According to Bono, “He was the answer to the prayers of mothers around the world who were desperate for the truth to be told.” A heartfelt Kennedy remarked how good it was to be home at the CHD Conference. He continued:

We were told to trust the experts—I can tell you that is not a thing. Not in science or democracy. But it is a thing in religion and in totalitarian governments. It is the opposite of science and democracy. In democracy you maintain a healthy fear of authority and maintain skepticism. Democracy is sloppy and messy and moves inefficiently. Totalitarianism is not messy. But the advantage of democracy is that ideas

that rise in the marketplace of ideas and are first yielded in the furnace of debate, will yield the best policies.

A Marketplace of Ideas

The final conference day was truly a marketplace of ideas. Attendees were able to attend breakout sessions in law, science, medicine, filmmaking, and advocacy. The chapters session was lively and inspiring with three+ hours of presentations dedicated to actions and activities. Approximately 20 of the 25 world-wide chapters (with three more on the way including the new CHD military chapter) presented wide-ranging plans and ideas from family farm days to legislative days. Many chapter representatives also visited exhibitors and attended a chapter dinner and Wakefield's new movie, *Protocol 7*.

In addition to the CHD Chapter Development Team, Catherine Austin Fitts, Carolyn Betts, JD; Mary Holland, CHD President; and Giorgio Zeolla, CHD Chief Development Officer attended the CHD Chapters breakout session. Zeolla emphasized that unity and joy is what puts fear into the hearts of people we are fighting and encouraged a sense of unity and joy in CHD work. Fitts lifted spirits with gratitude. She honored the work of CHD Chapters emphasizing that "One of the reasons I am grateful for CHD is for the Chapters. We need an army!"

We Have the Peace of Doing the Right Thing

Rise & Resist was a world event for those in the truth movement to find respite, to connect, and to gain tools and solutions to be better equipped for the challenges of tomorrow. To be sure, there are many reasons to attend a CHD Conference. But nothing compares to *that* feeling... the feeling of being surrounded by what Monica Smit, [Reignite Democracy Australia](#) and Reignite Freedom, referred to as a "freedom family"—a family filled with "bloody nice people!"

Smit identified two paths for our future—enslavement or one that is kind of rocky. She assured us that the CHD army is on the fun path. "We are on the right side of history and have the peace of doing the right thing... They do not know what that feels like." A freedom fighter who spent time in jail, Smit advised to show strength even if you have to fake it. The more you do it, the more real it feels...Be the person others wish they could be!"

Rising and resisting means many things... It can mean showing up at a rally or a meeting. It can involve writing a book or sharing a book. For others, it is sinking the Titanic! All these forms of rising and resisting take courage, a strong "rhinoceros hide," and a community. Smit summarized that there were a lot of people that were watching from the sidelines during COVID. She reassured that the next time they will not be silent. "We should be excited... We will be better people and more courageous. We are not afraid because we have communities. Don't feel alone and take positive action!"
